


#### Corvette Funfest – September 16th, 17th, and 18th, 2005

You can hear the Beach Boys and have a triple fun River City Corvette weekend at the Mid-America Motorworks annual event. Mid-America Motorworks is the Company that mails Corvette parts and accessories catalogues almost monthly to all of us. Every year, Company owner Mike Yager provides a free event to all Corvette owners at his Company headquarters in Effingham, Illinois. This year, the Saturday night entertainment will be the Beach Boys.
