Secretary's Report: Minutes for the January 22, 2012 were passed around and accepted without corrections or additions.

Treasurer's Report: : Mavis reviewed the income and expenditures for the last several months.

Governor's Report: Chuck reported he has finished the Car Show flyers for July 21, 2012 car show. The flyer was reviewed and it was recommended the "GM" disclaimer be added because the GM logos appear on the flyer.

Webmaster's Report: John reported he will post pictures this month.

Event Chairperson:

1) Dave & Kathy discussed attending God's Country Car Show March 17 at the La Crosse Convention Center as a club activity. It was decided the club would eat at Fat Sams after visiting the car show.

2) Tom & Claude are organizing a "Beater" gimmick rally on Mach 25 at 3:00 PM followed by the Club monthly meeting at Schmidty's.

3) Dave asked people to sign up to organize the monthly "Ride & Dine" typically held on the 2nd weekend of each Month. Volunteers were found for every month.

Old Business: President Tom reviewed old business:

 Club Liability insurance – a question was asked if club insurance was enforce for "spur of the moment" events. The event has to be on the official club calendar to be covered. However, the calendar can be quickly updated if needed to insure coverage.
Webmaster John Gesslein was recognized by Tom for his many years of service as the Webmaster and presented with a new name badge showing him as the Webmaster.

3) Club Trailer – the executive committee has decided to dispose of the trailer after all the trailer contents are dispositioned. The club will retain 24 orange pylons, fire extinguisher, and 10' x 20' canopy.

4) Club Timing Equipment is in Dave possession (maybe). Chuck reported the equipment is old, out of date and no longer supported. It was suggested we investigate selling it for parts.

5) IRS Not-For-Profit status. Tom reported he has been researching this topic and has discussed it with Attorney Greg Bonney. Mr. Bonney did the original application for the club in 1989. For a fee of \$100 and legal costs Mr. Bonney will complete the forms to reinstate the club as Not-For-Profit (NFP). Going forward we must renew annually. A member asked why we need NFP status. If the club is not NFP it would have to file a Federal Tax return each year on every dollar collected. Another member asked if we were Sales Tax Exempt for all purchases. The club is not sales tax exempt because it is a real hassle to maintain and we have minimal purchases.

6) NCCC Federal Audit – Tom reported the national club is being audited by the IRS and has already paid \$7900 in fines. More fines maybe assessed. This is why it is important to keep current on all the paperwork.

7) RCC Constitution – Tom received a current copy of the constitution from Jim. Tom is making it electronic and he will have it posted on the web in the members' only section. 8) Rotary Light – Carol reported the check from Rotary Lights will be awarded on March 28 at their 7:00 AM Award Breakfast held at the Holmen Village Hall. She and Tom will attend and pick up the check for \$235.

9) Sargent-At-Arms – Tom informed Dennis that Cyndy was appointed Sargent-At-Arms and will be presented her new name badge at the next meeting she attends.

6) FunFest @ Effingham, IL September 14 - 16. Discussed as a multi-day event and stopping at a car museum along the way.


7) Oktoberfest Car Show September 30.
